I. ROUTINE BUSINESS

The Mayor and City Council of the City of Bridgeport, Nebraska, met in regular session in Council Chambers, 809 Main Street, Bridgeport, Nebraska, on the 17th day of September, 2009, beginning at 5:00 p.m.

Following the Pledge of Allegiance to the Flag of the United States of America, Mayor J.W. Berg called the meeting to order. Roll call resulted as follows: Present: Gary Oltmann, Willis Beyer, Greg Lussetto, and Jason Schmunk; Absent: None.

Staff members present were: City Administrator Bill Boyer.

The Mayor presided and the City Administrator recorded the proceedings.

Mayor Berg announced, "In accordance with Section 84-1412 of the Nebraska Revised Statutes, the open meetings act is posted at the back of the Council Chambers for the review of the public."
